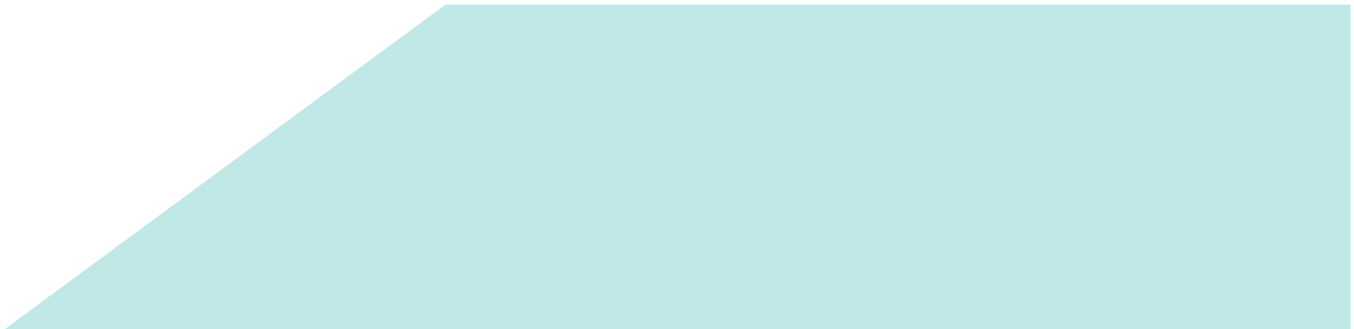

The Central Credit Register

The Central Credit Register is a national database that stores information on consumer and business loans. It is used to generate credit reports which borrowers and lenders can access.

Borrowers can access their credit report free of charge any time (subject to fair usage) to see what information is stored about their loans on the Central Credit Register.

Lenders can access borrower's credit report to help them when making decisions about loans and loan applications. Lenders must request a borrower's credit report when considering a loan application for €2,000 or more, and may do so, if the loan application is for less than that. In addition to that, a lender may obtain your credit report if:

- you have asked for a re-structure of an existing loan
- if there are arrears on an existing loan
- if you have breached the limit on a credit card or overdraft.

The Central Bank uses information contained in the Central Credit Register to gain better insights into national trends in the provision of credit.

By doing so, the Central Credit Register supports the Central Bank's obligations and functions to protect consumers, supervise the financial sector and ensure financial stability.

Service Standards

To enhance transparency around the operation of the Central Credit Register, this document sets out the Central Bank's performance against service standards that it has committed to in respect of services provided to borrowers, and lenders known as Credit Information Providers.

Note:

1. All standards are calculated from the time at which a request becomes valid, i.e. once all supporting documents are successfully received.
2. If a borrower finds information on their credit report that they believe to be incorrect, incomplete or not up to date, they have the right to request that it is corrected. We will respond with a decision not later than 40 days after we receive a valid application.
3. An explanatory statement is a statement of up to 200 words a borrower may place on their credit report which explains an event or circumstance about their loan or loans.
